Requirements for participation are as follows:

SELLER'S PERMIT

To participate you must obtain a seller's permit for the City of San Jose. For information please visit <http://www.boe.ca.gov/pdf/boe400spa.pdf>. If you already have a seller's permit in another jurisdiction you can register for a temporary sales location using your existing permit. For details please visit <http://www.boe.ca.gov/pdf/boe530b.pdf>. A copy of your seller's permit must be included with your application submission.

APPLICATION

Complete the attached seller's application. **Application deadline July 11, 2008.**

ORIGINAL WORKS

All works sold must be original and owned by the selling artist

BOOTH SPACE

Each booth space will be composed of a 6 foot table at a cost of \$25. The fee must be included with your application submission. Booths will be assigned on a first come first served basis. Artists may purchase more than one booth if desired however the per booth fee will still apply.

EVENT INFORMATION

The Art Expo will be held on Saturday, July 19th from 11AM-3PM at Gardner Community Center, 520 W. Virginia Street, San Jose. **Setup begins at 10AM.** All artists are responsible for the set up and clean up of their assigned booth areas.

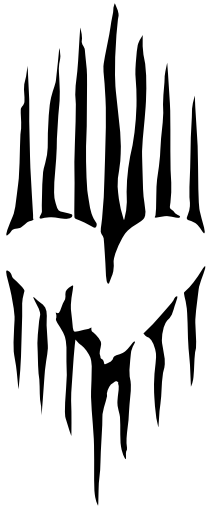

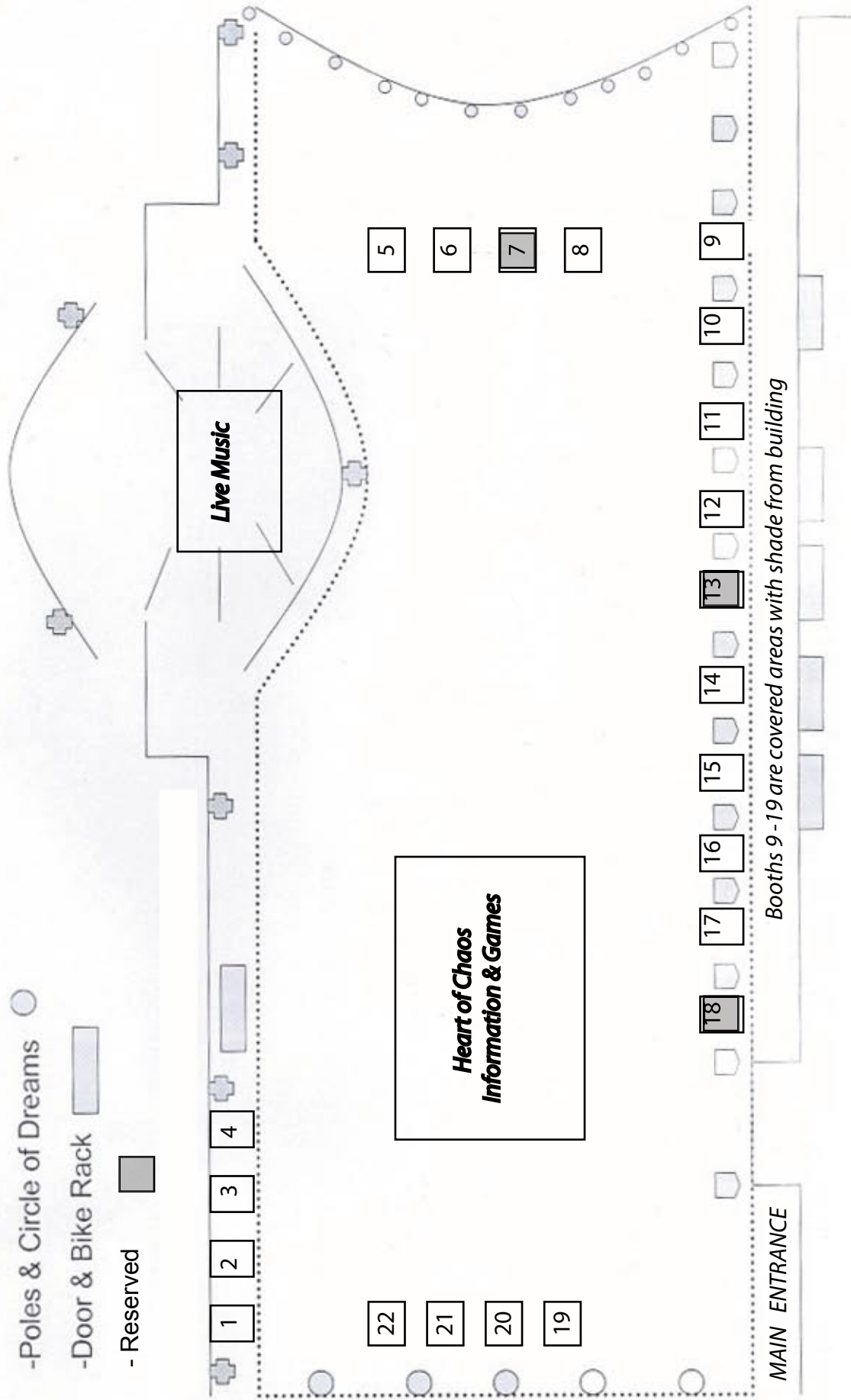
